1. The premises shall have a zero tolerance to controlled drugs and have a written drugs policy outlining what action will be taken in respect of individuals found in possession of drugs. A copy of this policy shall be retained on the premises and shall be made available for inspection by a police officer, a police licensing officer or officers of the local authority on demand.

2. All drinks must be served in toughened or strengthened glasses. On any occasion that the premises sells alcohol after midnight, no drinks will be served in glass bottles from which it is intended or likely that a person shall drink after 2300 hrs.

1. The premises shall operate a Challenge 25 Policy and any individual who appears to be under the age of 25 will be required to produce an approved form of photographic identification as outlined within the Torbay Council's Licensing Statement of Principles.
2. No persons under the age of 18 years shall be permitted in the premises after 2100 hours, unless they are consuming a meal in the company of a responsible adult, in which case they must not be in the premises after 2200 hrs.
3. An exception to under 18s being permitted on the premises after 2200 hrs shall be to attend a pre-arranged private function in the company of a responsible adult and where the premises are closed to the public.

Band E - £125001 and over £1,905.00

If you own a large premise you are subject to additional fees based upon the number in attendance at any one time

Capacity 5000-9999 £1,000.00

Capacity 10000 -14999 £2,000.00

Capacity 15000-19999 £4,000.00

Capacity 20000-29999 £8,000.00

Capacity 30000-39000 £16,000.00
