

## TEMPORARAY ACCOMODATION DATA ANALYSIS

N.B (Chart updated to End Sept 21) and is comparison with Figure 1 in TA Accommodation Needs Analysis




The number of blanks reported up to December 2018 reflect the old recording system utilised before the change to LOCATA.


The increase in single individual accommodated from January 2020 through to November 2020 was as a result of the governments Everyone In directive.



Table 2 illustrates the volume of TA proved for the same periods over the last 3 years. It also shows the percentage of the provision by bed need. Not only have volumes significantly increased, the need for family accommodation has also increased. This is also accompanied with increased pressure on accessing move on accommodation.
